2. **Fee:- Demand draft of Rs. 42100/- in favour of Director, PDUNIPPD payable at New Delhi**
3. Documents to be produced in original along with 2 sets of Photocopies

- I. Date of Birth Certificate, Matriculation, Senior Secondary School Certificate issued by Board/University.
- II. Certificate from the prescribed competent Authority for the candidate seeking admission under the reserved categories.
- III. Certificate of good conduct from the School/College/University last attended not later than 6 months.
- IV. Documentary evidence of having passed the 12<sup>th</sup> standard examination under 10+2 scheme.
- V. Marks Sheet of 12<sup>th</sup> standard board examination of 10+2 scheme.
4. Medical fitness certificate from a registered medical practitioner
5. Three recent coloured passport size photographs.
